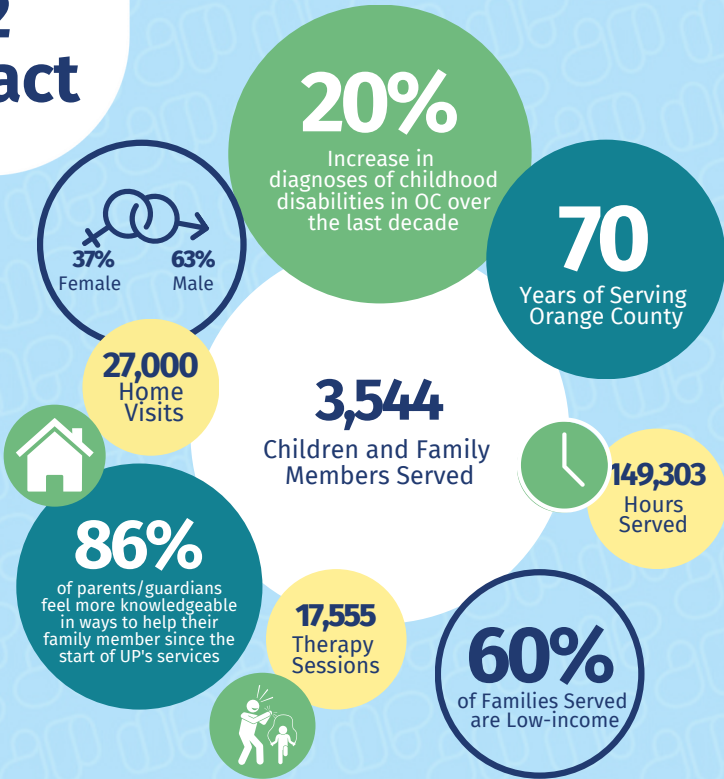

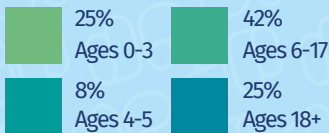

Ages Served

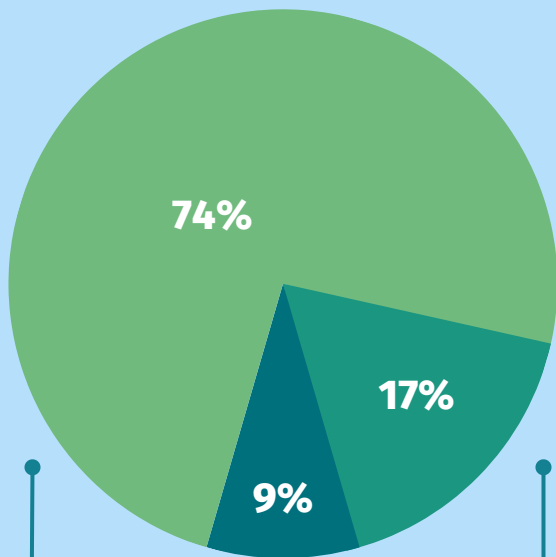

Beyond Limitations

Brianna's Story

Upon being diagnosed with cerebral palsy at two and a half years old, doctors told Brianna's family that she would face a lifetime of speech and movement challenges. After hearing about Unlimited Possibilities through a close friend, Brianna's family visited UP's Pediatric Therapy Center for the first time when she was just six years old. She soon began attending UP regularly for speech therapy, occupational therapy, physical therapy and recreational programs.

Over the next eight years at UP, Brianna's determined spirit continued to shine as she achieved countless milestones initially thought impossible by doctors. Brianna began communicating during speech therapy sessions through assistive devices, and eventually on her own. Through physical and occupational therapy, Brianna started building lifelong skills to move independently and transition in and out of her wheelchair. UP's dance, art, and karate programs provided Brianna with more tools to improve her mobility and sparked her confidence to dream big for the future.

As Brianna entered her teen years, she began modeling, acting, and won the 2017 title of the California Miss Amazing Teen Queen pageant. Now 23 years old, Brianna continues to shatter the limitations that others have placed upon her. With a supportive family and care team by her side, Brianna now lives in an apartment in Newport Beach while pursuing her professional modeling and acting career with an agency.

At UP, we believe no one should be defined by their disability or diagnosis. Every individual we serve has a story as unique as Brianna's, and through our life-changing programs we are partnering with families to help create their limitless futures.
